### Release and Waiver of Liability

PLEASE READ CAREFULLY! THIS IS A LEGAL DOCUMENT THAT AFFECTS YOUR LEGAL RIGHTS!

The Client hereby freely, voluntarily, and without duress executes this Release under the following terms:

**Release and Waiver.** Client does hereby release and forever discharge and hold harmless NTT and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from Clients Activities with NTT.

Client understands that this Release discharges NTT from any liability or claim that the Client may have against NTT with respect to any bodily injury, personal injury, illness, death, or property damage that may result from NTT's Activities with Client, whether caused by the negligence of NTT or its officers, directors, employees, or agents or otherwise. Client also understands that NTT does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance in the event of injury or illness.

**Medical Treatment.** Client does hereby release and forever discharge NTT from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Client's Activities with NTT.

**Assumption of the Risk.** The Client understands that the Activities include work that may be hazardous to the NTT Volunteers, including, but not limited to, construction, loading and unloading, and transportation to and from the work sites.

Client hereby expressly and specifically assumes the risk of injury or harm in the Activities and releases Habitat from all liability for injury, illness, death, or property damage resulting from the Activities.

**Insurance.** The Client understands that, except as otherwise agreed to by NTT in writing, NTT does not carry or maintain health, medical, or disability insurance coverage for any Client.

Each Client is expected to obtain his or her own medical or health insurance coverage.

**Photographic Release.** Client does hereby grant and convey unto NTT all right, title, and interest in any and all photographic images and video or audio recordings made by NTT during the Volunteer work for the Client.

**Other.** Client expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the State of New York, and that this Release shall be governed by and interpreted in accordance with the laws of the State of New York. Client agrees that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.
